During this period, he has acquired, financed, managed, renovated, repositioned, sold, and/or participated in the development process of more than 100 apartment properties (over 17,000 units) and more than 500 single family homes with an aggregate value of more than \$1 billion combined throughout Texas, Louisiana, Georgia and Colorado.

Griffin is a licensed Texas Real Estate Broker, a former licensed Louisiana Real Estate Broker, and a former licensed Texas Mortgage Broker.
